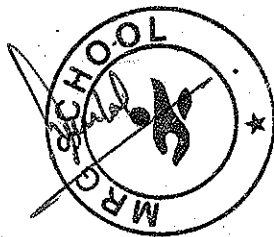

FIRE SAFETY CERTIFICATE

Certified that the **MRG School** (name changed from **Delhi International School**) at plot No. B-5, Sector-3, Rohini, Delhi comprised of **Basement + Ground + Four Upper Floors**, (**School is running at Basement + Ground + Three upper floor**) was granted NOC by this department vide letter no. **F.6/DFS/MS/School/2016/WZ/1418 Dated 19.09.2016 up to 3rd floor**. The premises were re-inspected by the officers concerned of this department on dated **23.06.2021** in the presence of **Mr. Rohit Gupta** and observed that fire safety norms as required under Rule 33 of Delhi Fire Service Rules, 2010 have deemed complied for entire building and that the building/premise is fit for occupancy Group B Educational for **basement + ground + three upper floor only** with effect from **7/7/21** for a period of **three years**, in accordance with the rule 36 unless renewed under rule 37 or sooner cancelled under rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules, 2010.

Conditions for validity of Fire Safety Certificate;

1. All the fire safety arrangement provided there-in shall be maintained in good working conditions at all times.
2. Loss of life or property due to non functional fire safety measure shall be at the responsibility of the management.
3. The trained fire fighting staff should be available round the clock.
4. Any deviation with regard to the construction etc shall be verified by the concerned building sanctioning agency.
5. This certificate cannot be treated in any case for regularizations of unauthorized construction.
6. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director along with a copy of this Certificate, six months prior to its expiry".
7. The owner / occupier shall submit a declaration every year in form "K" provided in the first schedule of Delhi Fire Service Rules 2010. The form "K" is available on
8. **The Fourth floor shall not be used for any occupancy violation of which shall be as FSC null and void of FSC.**
